### **Liberty School Scholarship Policy and Procedure Summary**

- Families seeking a Board Scholarship should submit an application and a copy of their most recent IRS Form 1040 and any other relevant financial information
- The school Scholarship Committee will review all applications and create an anonymous recommendation list of scholarship award recommendations for Board discussion, modification, and formal approval
- Recommendations are based both upon the funds available and the level of financial need
- By policy, scholarship awards can not exceed 50% of total tuition
- With an eye toward sustainability, no more than 20% of projected gross tuition revenue shall be awarded as scholarships
